- T. Telehealth (TH) uses telecommunications (e.g., Internet, landline, or mobile phone) as a method to provide healthcare remotely to improve hypertension (HTN) control.
- E. Effectiveness of TH on HTN control among disparate populations.
- L. Long-term blood pressure control is carried out.
- E. Ease in scheduling, communication, monitoring, and management for patients and practitioner
- H. Healthcare providers, health plans, and decision-makers about the benefit of using TH to improve HTN control in a large population.
- E. Ease and immediacy of communication
- A. Access to care is increased to patients; otherwise, they may not receive the Potential for increased liability for practitioners.
- Affordable, effective, and efficient ways to reach and support minorities
- L. Long-term blood pressure control is being implemented
